Dear Master Gardener Applicant:

Thank you for your interest in the Extension Master Gardener Program in Fort Bend County. We are a 501(c)(3), Tax Exempt Texas Corporation with 174 members.

Please read this letter carefully and complete and sign the enclosed Master Gardener Application, Video, Film, and Photographic Image Release Form, and the Volunteer Application Form. Once we receive all of your paperwork, you will be sent information from Sterling Volunteer, background check platform. Texas A&M AgriLife Extension Youth Protection Standards (YPS) – Qualifications of Volunteers Program was implemented to provide a safe and positive environment for youth and adult volunteers. The YPS program involves national criminal background checks of all adult volunteers 18 years of age or older who are involved in educator roles, which includes Master Gardeners. Before you are confirmed in the program, you will have to submit to a background screening.

Please return your completed Master Gardener Application, Video, Film, and Photographic Image Release Form, and the Volunteer Application Form with payment on or before 2:00 pm Friday, July 19, 2024, by either email, USPS or you are welcome to drop it off at our office during business hours. Payment by the Paypal link, check, or exact cash will be accepted. Cost of the training is \$250 per individual, or \$420 for two people, if a handbook is shared. You will receive the Extension Master Gardener Handbook, in full color at the orientation. Completed applications accompanied by payment are considered on a first come, first-served basis. We will review the applications and notify you by Monday, August 19, 2024, regarding your status in the program. Space in class is limited, and preference is given to Fort Bend County residents, however, there are exceptions. We will also require that all accepted applicants attend an in-person orientation on Thursday, August 29, from 9:00 am to 3:00 pm. If in doubt, please call 281-633-7029.

The following information will help you better understand the functions and requirements of the Extension Master Gardener Program. The purpose of the Master Gardener Program is to extend the ability of the Texas A&M AgriLife Extension Service to provide education programs to the public in areas of horticulture and gardening through the use of Certified Master Gardener volunteers.

Becoming a Master Gardener requires training in horticulture. Classes will be held on 12 consecutive Thursdays at the Texas A&M AgriLife Extension - Fort Bend County facilities on Band Road in Rosenberg beginning on September 5, and concluding before Thanksgiving. The majority of the instruction will take place from 9:00 am to 1:00 pm with additional hands-on activities from 1:30 pm to 3:00 pm. You will need to bring a lunch to class. You are expected to **attend all classes**. Please arrive by 8:45, and be prepared to stay fifteen (15) minutes after class for Q&A and announcements. Most classes are taught remotely by Professors and Extension Specialists from all over the State of Texas, while others are taught by Master Gardeners. Each week, there will be a reading assignment with tests and continuing instruction on next steps in your Master Gardener journey.

In addition to the training class days, there is also a requirement that you complete 50 hours of **approved** volunteer service. All class members will have demonstration gardening opportunities, learn about the greenhouse, propagation, the Master Gardener helpdesk for public queries, outreach, Junior Master Gardener program, plant sales, to name a few. You'll have 8 months from the first day of class to complete the volunteer hour requirements (May 5, 2025) and you are welcome to begin volunteering once the classes are underway.

After completion of all the class and volunteer requirements, you become a Certified Extension Master Gardener. However, you don't always remain a Certified Master Gardener unless you maintain your Certification through annual volunteer service of 24 hours, and annual continuing education of 12 hours. We help you through our own educational programming and volunteer opportunities and approving other outside educational events.

So, what kind of people are we looking for? People with a strong desire to learn and to share their knowledge with the public in a variety of ways, including speaker's bureau, writing articles, maintaining demonstration gardens and much more. If you are looking for educational classes for other reasons, we have many to offer and encourage you to check out our Grow Your Own Gardening Series and Landscape Success Lecture Series.

We thank you very much for your interest in this exciting volunteer program to expand research-based gardening knowledge and proficiency for the Fort Bend County communities.

The Fort Bend County Master Gardener training program duration is eight (8) months. Upon completion of all requirements, on May 5, 2025, participants will be certified as Extension Master Gardeners. Master Gardeners then re-certify annually through volunteer service and continuing education.

I desire to be a Master Gardener volunteer in Fort Bend County. I understand that Master Gardeners are trained volunteers - community educators, who share their horticultural knowledge and gardening experience with their fellow citizens.

Extension Master Gardeners must not use the title, in any form of advertisement. Implying Texas A&M AgriLife Extension endorsement of any product or place of business is improper. The Extension Master Gardener program is a public service program operated by Texas A&M AgriLife Extension to provide unbiased information, and the Extension Master Gardener title is to be used only when doing **unpaid volunteer work** in this program.

Participants are required to complete a minimum of 50 hours of class training, and a minimum of 50 hours of volunteer service prior to graduation, which is approximately 8 months after the first-class date. Thereafter, in order to maintain certification, Certified Extension Master Gardeners in Fort Bend County must complete 12 hours of continuing education (CE) and 24 hours of volunteer service every year.

Liability Release:

Extension Master Gardener Volunteer Agreement

We appreciate your commitment to the Extension Master Gardener program. Your satisfaction and progress in this volunteer position are important to us. Please read the following expectations and indicate your willingness to cooperate by signing at the end of this form. This form must be signed and filed with the county Extension office and will need to be updated every three years. Volunteers not adhering to all items in this agreement may forfeit their certification as a Master Gardener volunteer.

I understand that I am trained by Texas A&M AgriLife Extension Service in the field of Horticulture, and I am expected to extend research-based information to the public on behalf of Texas A&M AgriLife Extension. In exchange for the minimum of 50 hours of Master Gardener Training provided by Texas A&M AgriLife Extension Service, I will:

- Commit to a minimum of 50 hours of volunteer service to the horticultural programming efforts in <u>Fort Bend</u> County within one year to become a certified Master Gardener.
- I understand that to maintain active status as a Master Gardener Volunteer, I must volunteer <u>24</u> hours annually after my intern year and gain <u>12</u> continuing education hours annually.
- Provide a record of this service as directed by the Master Gardener Program Coordinator.
- Comply with the Texas A&M AgriLife Extension Service Background Check policy. The background check is to be renewed every three years.

Please read the Extension Master Gardener Management guide found at <u>https://txmg.org/administration/management-guide</u> for further details on the Master Gardener program, volunteerism, and Texas A&M AgriLife Extension.

When acting as an Extension Master Gardener volunteer, I agree to:

- Consistently exhibit a positive professional manner toward and about Texas A&M AgriLife Extension Service, the Master Gardener Program, the Master Gardener Coordinator, other Master Gardener volunteers, other Texas A&M AgriLife employees, and clients.
- Carry out and discharge all duties in a responsible and timely manner.
- Avoid any conflict of interest
 - Not use my Master Gardener status to promote any commercial activity or private business.
 - Volunteer's efforts at their place of employment will not be considered volunteer service to Texas A&M AgriLife Extension Service.
- Recommend and use (when functioning as a Master Gardener) Texas A&M AgriLife approved information for any public pesticide, herbicides, fertilizer, or cultural practices.
- Provide my own transportation and pay my own expenses incurred as part of official volunteer activities. (Expenses may be tax deductible with proper documentation.) Some County Master Gardener Associations <u>may</u> assist volunteers with expenses for certain types of events. Check with your local Master Gardener Program Coordinator for more information on specific association policies and procedures.

- Act in accordance with the highest standard of ethics:
 - Not physically, verbally, or sexually harass/abuse anyone
 - Refrain from illegal or unsafe behavior
 - Dress appropriately and not use harsh language
- All work by a Master Gardener text, written, spoken, images, photos, illustrations is expected to result from the Master Gardener's thought, research, or self-expression. All outside work sources (text, written, spoken, images, photos, and illustrations) must incorporate appropriate attribution. Failure to comply is plagiarism and puts the Extension Master Gardener program and the Master Gardener at risk of copyright infringement.

In regard to Master Gardener Coordinators, Master Gardener volunteers will:

- Recognize the responsibilities of the Texas A&M AgriLife Extension Service staff/ Master Gardener Coordinator in setting program priorities, standards, and direction. Specific projects for the performance of the volunteer work are determined locally and should reflect local needs.
- Refer all commercial horticulture inquiries to the Master Gardener Coordinator or other Extension staff.

In regard to Master Gardener Colleagues, Master Gardener volunteers will:

You will be contacted within two weeks of the initial communication.

I also understand that I am not covered by workers' compensation laws in connection with my volunteer affiliation.
