### **Herbal Studies Program**

The following words mostly came from Kim Pringle back in 2018 when she was summarizing our group for the VMS of that time:

"The Herbal Study Program is to educate BCMGA members and other persons interested in knowing more about all herbs: participants periodically volunteer to lead the group on one or more topics; service the two herb demonstration beds on the Texas AgriLife Extension Service Office grounds; and coordinate program requests through the BCMGA Speakers Bureau. The study meetings are designed to be manageable around first-Wednesday landscape and grounds work as well as Burger Wednesday activities.

"Attendees participate by one or more of the following, or something similar for each herb to be studied: 1. conduct approved research on the herb and report one finding about growing conditions or uses, etc. 2. if growing the herb, describing one's personal experience, perhaps augmenting with photos and specimen samples. 3. use the herb in a project, for instance bring a recipe that includes the herb and/ or a sample for others to taste.

"Two recommended books for growing herbs in Central Texas are **Southern Herb Growing** by Madelyn Hill and Gwen Barclay and **Herbs for Texas** by Howard Garrett."

As you're already aware, we're resuming our monthly meetings on the first Wednesdays, starting on August 4<sup>th</sup>, promptly at 9:00 a.m. in the Texas AgriLife Extension Office classroom. We'll examine *bamboo* and then on September 1<sup>st</sup> we will continue the topic with a presentation by the Bamboo Guru himself, Kinder Chambers, of the Texas Bamboo Society, who will also answer our by then more educated questions.



# Fall Plant Sale

### **Vegetable Growers Wanted!**

The BCMGA will hold a fall plant sale on October 2nd at the Extension facility. We have recently been purchasing the vegetable plants that we sold. We have always been limited to what was available from the grower. For the sale this past spring, we grew some plants and purchased some. For the fall plant sale, we would like to focus on growing vegetable plants for sale as our primary source. I would like for us to focus on growing the varieties that are on the aggie-horticulture.tamu.edu site that are known to do well in Bell County. The only Texas Superstar vegetable appropriate for planting this time of year is Green Magic broccoli, so I want to make sure we have that too. The plants that can be transplanted in October include:

Asian Greens, Broccoli, Brussels sprouts, Cabbage, Cauliflower, Collards, Kale, Kohlrabi, Lettuce, Mustard Greens, Spinach, and Swiss Chard.

Each of these have multiple varieties on the aggie-horticulture site, so we should be able to offer at least two or three of each. I plan to hold a seed starting session on August 18th , starting at 09:00 at the learning center. I will teach a dense seed starting technique at that session. We will meet again on September 1st with your seedlings to up-pot them into 4" pots. That will give 4 weeks of growing time to get plants that should be at their prime for the sale. Look at the list of recommended varieties and if there are any personal favorites, let me know.

# Herbicides

#### An Article on herbicides submitted by Charles Newsom

If you are a licensed applicator, you are aware of the many regulations that apply to herbicide use. The beginning of each label contains personal protective equipment, pants, shirt, gloves, eye protections, respirator, and any special requirements. Another section covers first aid if the product gets on your skin, is inhaled, gets in your eyes, or if you swallow it. Disposal of the container is found here also. Triple rinse the container and puncture it so it cannot be reused Dispose of the container as directed. Carefully read and comply with all the requirements listed and keep a record of the application.

There are a few organic herbicides. Acetic acid, clove oil, cinnamon oil, d-limonene and sodium chloride. These products can be found by searching organic herbicides on line. Being organic does not mean they are any less toxic to plants or that they deserve any less care in handling or application. There are literally hundreds of inorganic herbicides. They can be primarily grouped into pre emergence and post emergence. If you have a plant that is annual, the germination of that plant can be prevented by the timely application of a pre emergence product. Be sure you do not plan to plant in the area where the product has been applied. The product may also have soil activity of more than a year or plants that cannot be planted next year. Be sure to read the label carefully and follow the directions for application.

Post emergent herbicides have been customized to address specific plants. If you want a non selective product to clear a fence row, there is a product for that. If the target weed is a sedge, there is a product for sedges. If the target is a grass there is a product. There are several products for woody plants and vines. Again read and follow the label carefully and apply as directed. Using a greater concentration is not more effective, just more costly. Do not mix more product that you plan to use.

A final comment. You may not need a license to purchase the product, but treat every herbicide carefully. Drift onto your neighbors plants can be serious. I have had instances where a neighbor applied 2-4-D and it drifted over a half mile onto my tomatoes. Some plants--grapes, vegetables, ornamentals, fruit crops and cotton for instance-- are very sensitive. When you are finished with the product, dispose of the container and any unused product properly. Also herbicides may reside in hay, grass, compost, and manure as a residual with bad results if they are used on desirable plants. I applied Chaparral (Dow AgroSciences) this year. Chaparral has an 18 month restriction on hay, manure and grass for potatoes, beans, lettuce, tomatoes, etc. The hay can only be used on the farm/ ranch where it was produced.


