## **Event Concession Vendor Contract**

- 1. Vendors are required to have proof of the appropriate permits, licenses and insurance required by law available.

3. No utility services are provided. Tables, Chairs, Tents, and other items are not provided. Vendors must provide all their materials. Vendor space shall follow all applicable laws and regulations of the City, County, and State for said Event.

- 4. Description of vendor station contracted:
- 5. Vendor will be given access to the place that is agreed upon by both parties no less than one hours before the beginning of the Event to set up the Vendor's station, goods to be sold, and anything else that is needed and customary to vend at that specific location.
- 6. The Vendor will not vend any items or services that are not disclosed here at the Event without prior written consent from the Host. Items that will be sold:
- 7. Vendor's staff may exhibit their goods for sale only while the staff is within the area of the vendor's specified location.
- 8. Vendor and staff will be properly dressed, their appearance will be clean and neat, and they shall conduct themselves in an orderly fashion. They will not wear any clothing, pins or labels that promote religious, political, or profane images or wording.
- 9. There is to be no loud distracting music, noise, and or sound amplification devices used by Vendor's staff at the abovementioned Event.
- 10. Absolutely NO Alcoholic Beverages are permitted ANYWHERE on the Event Property.
- 11. Vendor will have access to the location for up to 2 hours following the close of the Event to dismantle and remove all items brought to the Event by Vendor. Vendor shall leave the location free from trash and leave it in similar condition that it was in before the Vendor was there.
- 12. Vendor agrees to hold the Host free from any damages or claims that may develop in connection with participating in the above-mentioned Event.
